## **I. Current Insights and Future African Superpower Dimensions**

### **1. Laying the Foundations from the Current Economic Insights to the Future Aims and 2080 Expectations**

Africa possesses over 874 million hectares of lands suitable to agriculture, of which only about 250 to 274 million hectares are currently under cultivation or being exploited—representing approximately 28% to 31% of the total arable and suitable agricultural lands. This means Africa still has nearly 600+ million hectares of untapped arable lands, which is 60% of the global reserve, offering the largest opportunity for agricultural expansion on the planet. By 2080, Backed by a strong visionary leadership, UNCACED aims to get 90% of this potential judiciously and sustainably cultivated to redefine the future of global food security systems for nearly 3.8 to 4 billion people in across the continental Africa and more than 10.4 billion people on the global planet, while drastically transforming the natural, ascending and crescent power of modern African economies.

Agro-sector employment still is 20%-30% informal, covering on itself (unfortunately) over 60% of Africa's workforce. This means around 80-70% of agro-employment remains informal, low-wage, low productivity and subsistence-driven. In regard to this, the UNCACED 2080 Agenda is a strong transitional promise and an unprecedented sectoral paradigm shift, whose reforms aim to achieve a new momentum of modern agro-industrial empowerment, unprecedented agribusiness growth revolution, highly advanced investments and a new sectoral transformation era that will absorb young professionals and create scalable 480+ million formal high-skilled jobs of the times—therefore catalyzing rural development and reversing urban slums.

African Agriculture contributes 20–30% (either 600-750 billion) of Africa's GDP, with a market value projected to reach 1-Trillion by 2030. Under the UNCACED structural reforms and value chain expansion, the 2080 Agricultural Agenda is engineered to contribute 40-45% (either 5.7 trillion) of GDP, with a Pan African Agribusiness Market Value expected to reach 8-9.5 trillion in minimal annual average.

Africa currently total over 60 Billion in food imports, and total around 40 Billion exports in raw agricultural products per year. With strong reforms and value-chain integration, UNCACED envisions a boldly structural transformation that will multiply and diversify the continent's agricultural export sector, boosting massive growth from agro-industrial exports, mobilizing an export revenue exceeding \$4.8 trillion in annual output by 2080, and evolving the continent from a net importer to a global leading exporter of high-value, thus shifting from raw to value-added export economies.

Africa faces significant challenges in achieving food security. Our Pan African Socio-Ecological Market Economies Policies are inclusively shaped to inspire, integrate & revolutionizing social equity, ecological sustainability, sovereign social market economies efficiency, food, land and climate justice, community wealth redistribution, ecologic trade ethics and green transformation financings transition, as well as bold aims and globally driven local ambitions for new prosperity and inclusive progress. Their future impact on humanity and African planet stands beyond the headlines: a modern visionary steadfast shift that will dignifiedly feed over 3,8 Africans, and export ethical food solutions to Global 50+ food-insecure nations. It'll mitigate climate risk through ecological stewardship, achieve a strong ecological regeneration of land by the restoration and revitalization of 400+ million hectares of degraded lands and strengthen Africa's role as the world largest carbon sink and climate balancer. ## IV. STRATEGIC ENABLERS AND INSTITUTIONAL MANDATES

### 1. AFRILANDER

Afrilander is envisioned as a custodian and pan African sovereign authority for tenure, governance and land reforms revolution in across the continental region. It calls both to binding ethics and principles for co-ownership and stewardship of African lands.

Under the Pan African Agrarian Revolution Charter, Afrilander is dedicated to establish a unified secure and inclusive pan African land governance system that empowers communities, drives agricultural transformation, protect indigenous sovereign rights, and underpins Africa's sustainable prosperity aligned with the 2080 Agenda for Africa.

#### Afrilander's strategic investment pillars include:

##### **Redefining Rights, Guarantee and Land Sovereignty and Tenure**

Establishing land as a strategic sovereign asset tied to socio-economic emancipation, and ecological stability.

Affirming the principle of land identity and belonging to African nations and aboriginal peoples, not subject to foreign dispossession or abusive and extractive appropriation.

Under **AFRILANDER**'s legal and technical power (aligned with pan African supervisory bodies and authorities), the Agency develops, adopts and enforce the **LERRA** (Pan African Land Equity, Regeneration & Redistribution Act), a CERM (Community Equity Redistribution Mechanism) to redistribute access and land co-ownership to indigenous communities and farmers' socio-cooperative SMEs (under the commonlands vision) backed binding protocols and commitments for responsible tenure, land beneficiation, and community reinvestment.

Under the LERRA, Land Equity Programs settled on dedicated quota and secure land rights policies will be implemented by Afrilander as for indigenous peoples & vulnerable or marginalized citizen groups

## **Leading Federal Transition and Decentralized Agrarian Governance**

Pan African federal decentralized agrarian governance systems refer to an envisioned transformative framework that restructures agrarian governance, shape the continental policy cohesion, and decentralize national implementation mandates where each state tailors federal policies to local contexts into a multi-tiered, sovereign yet interconnected architecture. This transition involves:

Establishing a universal code and a pan African land governance charter harmonized with national constitutions, customary laws, and modern pan African structures

Engineering a new model of a pan African agricultural governance that links land stewardship with decentralized, participatory leadership and localized prosperity.

Introducing and establishing Integrated Afridigital Land Registries and Pan African E-Cadastre-driven strong GIS and smart agro-land data systems.

Modernizing and streamlining administrative process for land access and acquisition on continent scale—shift towards e-banking, digital land titling & smart contracts under Afridigital Blockchain.

Establishing a steadfast regional geospatial mapping, ensuring tenure security and the demarcation of agro-productive, ecological and strategic-led investment lands on the continental scale.

Investing in land research institutes and public agro-scientific innovation policies.

Eradicating corruption, speculation, conflicts & land grabbing through highly endowed tools and diligent enablers.

Strengthening strategic and decentralized monitoring for performance contracts, land lay out ethics and agrarian resource beneficiation pledges throughout urban and rural areas.

## **Driving Land Transition focused on Modernization and Regional Transformation**

Developing policies and enforcing Land Investment Safeguard Protocols as continental mechanisms to protect African lands from extractive, and neo-colonial land grabs, employing land as an African catalyst for development, industrialization, agriculture, infrastructure, urbanization, and habitat modernization. This anchors (inter-alia):

Shaping dynamic, transformative and progressive laws and bylaws, and balancing opportunities between continental regions, aboriginal peoples, migrants, and investors.

Bridging and on-warding sustained reforms and robust policies focused on securing vast reserves and major land capital banks to accelerate giant projects for human settlements, farmland belts and industrial corridors development, territorial lay out and

urban-rural transformation, infrastructure revolution and habitat modernization, as well as unlocking cross-borderland synergies linked with highly widened views on public-private alternative eco-parks, mega wildlife and bioconservation centers, transnational eco-tourism industry hubs, broadened cross-regional economies & strategic sovereign investment clusters.

## 2. ACSIA

As a sovereign investment engine, ACSIA will secure \$2 (two) Trillion **PASIFUND**—Pan African Agro-Sovereign Investment Fund (with initial \$850B capital by 2035) to deploy **1000 Agro-Industrial Mega Hubs (AIMHs)**—established as major structuring agro-industrial clusters near pan African railways, ports, and farm belts over 180 million hectares of arable land secured under IP<sup>3</sup>Hs Models—catalyzing the transformation of raw produce into higher-value goods and green wealth manufacturing by 2080.

Under ACSIA's leadership, the pan African agriculture is expected to be repositioned, not as a subsistence sector, but as a sovereign industry of strategic power and global influence, structurally rising to:

Together, these institutions are destined to underwrite the 2080 agricultural revolution agenda, asserting it as not a merely food solution, but an economic leap toward ending poverty, manufacturing resilient prosperity, and inspiring regenerative economies and global generational sovereign wealth.

### 3. UNCAIDA

The **Agency of the United Nations and Communities of Africa for Continental and International Development Aid, UNCAIDA** is framed as UNCACED's sovereign aid and social transformation subsidiary dedicated to the structural realization of the 2080 pan African agriculture agenda, strategically anchored in a pan African architecture for agricultural socio-ecological economies.

Organizing pan African events, sessions and summits where farmers come together to share knowledge & experience gained over time, discuss encountered challenges, exchange ideas, and spark new groundbreaking pathways of progress.

Conducting and strengthening awareness campaigns through pan African summits, community and regional broadcasting sessions, as well as posters events to promote the importance of sustainable farming for food security, environmental health, and socio-economically regenerative reintegration.

The agency ensures economic, industrial, technological, and legal strategies are designed and crafted to relocate, relink, and reconstruct global and regional production chains back to the African continent, with domestic sovereign control over each value-added segment. It'll be entrusted to:

Shaping industrial localization requirements: ensuring mandatory local transformation quotas for materials exports—preferably 100 percent domestic processing, by issuing policy incentives for foreign firms to relocate manufacturing hubs to Africa.

Ensuring policy pipelines for technology and skills transfer under SCIIECO Structures  
Underwriting the CVCRA as a sovereign framework for sovereign wealth, and financing source for the CSTFs and CSIRFs.

Mapping strategic sectors for immediate repatriation

Inversing cultural dependency on foreign value creation systems

Ruling and governing pan African structures and branding, certification, trademark, IP retention, and ownership systems

Ensuring the continent no longer export value, but manufactures it, owns it & globalizes it on its terms.

## KEY BUDGETARY ESTIMATES

Estimating the true needed budget for UNCACED to spur and achieve the Pan African Agricultural and Food Revolution Agenda by 2080 requires accounting for long-term, continental-scale transformation across various interlinked pillars. Based on precedent mega-agendas, a realistic, high-impact budget would range between USD 3–5 Trillion (2025–2080).

### Why this scale is justified, reasonable and necessary?

The USD 3–5 Trillion scale is justified by the sole reason that:

The UNCACED's Africa 2080 Agricultural & Food Revolution Agenda is not envisioned as a sectoral plan, rather a continuous continental transformation blueprint, structurally invested in generations, over multiple decades.

The cost of hunger in Africa already exceeds 35 billion per year, while the burden of poverty demands trillions in long-term strategic investments to be effectively and completely eradicated. This dual crisis underscores the urgent need for bold solutions that structurally address the root-causes of food insecurity, systemic poverty, and economic vulnerability as interlinked challenges, requiring transformative policy, infrastructure, financings, and powerful inclusive development frameworks.

With a high demographic pressure backed by a population projected under UNCACED to exceed 3.8 billion by 2080, with over 60% being youth. Feeding this population sustainably, nutritiously, and sovereignly demands massive investments in a bold production, distribution, and food systems transformation that take into account global needs and realities.

At the intersection of the duty & the UNCACED central promise to secure multimillions of best paying and decent jobs and the current situation where large portion of Africa's workforce remains in low-productivity, informal agriculture, the cost of the modern continental job transition in Africa call absolutely to multitrillion scale agenda, anchoring and deeply embedding structural employment transformation and sovereign jobs-driven motivation. The revolution must fund the transition into formalized, high-value agro-industrial and agri-service jobs across rural and urban economies. Considering human capital as core investment, a justified multitrillion-dollar budget must prioritize training, skill-building, and employment schemes that directly translate public spending into productive labor force empowerment. In regard to youth & demographic dividend, by 2080, Africa will have the largest working-age population globally. The budget must target job creation to absorb this youth bulge, turning demographic pressure into economic power. Sovereign employment must eradicate public poverty, hunger, and socioeconomic instability. Investing in labor-intensive sectors like agro-processing, logistics, and infrastructure builds resilient communities and sovereign economic independence. Budgeting for sovereign employment must be led in the ways to convert public investment into long-term self-financing economic cycles. In essence, sovereign jobs motivation will transform the budget from a cost into a strategic lever for economic sovereignty, human dignity, and structural prosperity by 2080.

To confirm full continental agro-industrialization, and establishing thousands of agro-processing hubs, modern farms, storage and logistics networks, rural energy systems, and high-tech agricultural value chains requires major capital investments continent-wide. Technological empowerment and future sovereign agricultural industrialization ecosystems require billion upfront and long-term research & innovation investment.

With undisputable ecological regeneration and climate resilience requirements, Africa, under the 2080 Agenda must climate-proof its agriculture—thanks to the deploying of unconventional portfolios and unwavering major ecologically investment financial concessions expended over decades.

The human capital imperative in the 2080 Agricultural Agenda hinges on a bold vision and unwavering deployment of a multibillion curriculum that strategically integrate colossal investments and robust financial capital flows into structures & neo-pioneering architecture. This agenda must be anchored in a bold framework, fusing research, science, technology, engineering, agriculture and innovation with skill-intensive, future-driven training ecosystems for a high cultivated, specialized, and innovative expertise. The goal is to engineer a skilled next-generation workforce—empowered by pioneering excellence and skill capitalization platforms capable of sustaining and accelerating Africa's agricultural and food systems transition across all sovereign and regional levels. This human capital revolution is not merely a component rather a foundational handle for achieving food sovereignty, cultural self-reliance, and sustainable agro-industrial power by 2080.

For regional and international trade transition, structuring and integrating agricultural market economy in interconnected cross-regional and intercontinental rail, road, port, air and digital networks between African 55+ countries & the world requires mandatory unprecedented multibillion infrastructure-intensive investments.

Investing in institutional transformation & establishing and operationalizing sovereign institutions (like ACSIA, INTERTRAIDE, AFRIGUARANTOR, AFRILANDER, CVCRA, AFRISIED, UNCAIDA, ACSELA etc.) financial scaling, land reforms, and agriculture, trade, labor and food governance will need long-term operational capital and sovereign capacity-building.

With critical sight to global competitiveness, for Africa to become a global leading agricultural and food powerhouse, it must match or exceed investments made in Asian and Latin American green revolutions—which historically involved trillions over 40–50 years. This isn't excessive. It's not a conventional agri-budgeting, but a civilizational investment, proportionate to the scale, vision, and urgency of pioneering and fueling inclusive food sovereignty, economic transformation & pan African power for planetary regeneration and world cross-generational prosperity.

In Summary, achieving true food sovereignty, value scale, and complete agricultural transformation in Africa demands bold trillion structural investments over multiple decades. A total investment of \$3–5 trillion from public, private, sovereign, diaspora, philanthropic and multilateral horizons will be needed to re-author and re-igniting a self-reliant, high-yielding, technologically advanced, culturally empowered & progressive, globally inclusive, environmentally promising and economically prosperous agricultural and food ecosystem across Africa by 2080, under UNCACED federal leadership and its strategical agencies.
